   (3) Funding needs and resources, (4) Targets of achievements, and (5) Long-range plans
- To carry the mission of SCDC out into the community daily

#### FUNDRAISING:

- To use knowledge, influence and contacts to bring new supporters to SCDC.
- To contribute personally through an annual membership donation.
- To seek memberships for SCDC by making personal contacts in the community from neighborhood residents, businesses, and churches.

**FINANCES**: To assure fiscal responsibility by approving the annual budget and overseeing adherence to it.
